## 1 Introduction

## Acknowledgements

Acknowledgements should follow immediately after the conclusion.

**Author contributions** This is optional. If desired, contributions should be succinctly described in a single short paragraph, using author initials.

**Funding information** Authors are required to provide funding information, including relevant agencies and grant numbers with linked author's initials.

## A First appendix

Add material which is better left outside the main text in a series of Appendices labeled by capital letters.

## B About references

Your references should start with the comma-separated author list (initials + last name), the publication title in italics, the journal reference with volume in bold, start page number, publication year in parenthesis, completed by the DOI link (linking must be implemented before publication).
